1. \$30 is due at the time of registration in order to hold a place for each child registering. **Registration fee is nonrefundable and nontransferable. Your current month and last month tuition are also due upon registration. If you chose automatic funds withdrawal, you are not required to pay for your last month at the time of registration.**
2. **Fees are due by the 1st of each month. A \$15 late fee will be charged after the 10th of each month. Any account 60 days past due can be turned over to collections at the discretion of JFJ Elite and customer will be responsible for expenses and collection fees.**
3. **Your child is registered for the August through May session with JFJ Elite Gymnastics. A 30-day written notice is required if your child will be withdrawing from class in order not to be liable for the next month's fees**
4. JFJ Elite Gymnastics is not responsible for articles left at the facility.
5. Children must not leave the facility without a parent or guardian. Please instruct your child to wait inside the facility.
6. In the case of closings due to illness, or etc, you will be notified by phone or by a notice posted on the door of the facility. Should inclement weather arise JFJ Elite will have a message on the answering machine.
7. JFJ Elite is authorized to act for me according to their best judgment if I am unable to be reached in an emergency situation requiring attention.
8. I give permission for my child's picture or likeness to be used in publications or advertisements for JFJ Elite.

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT ("AGREEMENT")
